

**SCHOLARSHIP REGULATIONS  
OF THE TECHNICAL UNIVERSITY OF KOŠICE**

**FULL TEXT**

*In accordance with Article 9 (1b) and Article 15 (1j) of Act No. 131/2002 Coll. on Higher Education Institutions and on the Change and Supplement to Some Acts as amended by subsequent provision, and according to Article 49 (3j) of the Statute of the Technical University of Košice, the Academic Senate of the Technical University of Košice approved the Scholarship Regulations of the Technical University of Košice as the internal regulations of the University which, as amended by Amendments No. 1 to 7, reads:*

**Article 1**

**Basic provisions**

(1) The Scholarship Regulations of the Technical University of Košice (hereinafter referred to as the "Regulations") are issued in accordance with Article 13 of the Statute of the Technical University of Košice, Articles 95 to 97 and Article 54 (18) of Act No. 131/2002 Coll. on Higher Education Institutions and on the Change and Supplement to Some Acts as amended by subsequent provision (hereinafter referred to as the "Act") and regulate the provision of scholarships to students of bachelor's, engineering, master's and doctoral study programmes at the Technical University of Košice (hereinafter referred to as the "TUKE").

(2) TUKE provides its students with scholarships from the following sources:

- a) from the state budget,
  - b) from its own resources, i.e. from the scholarship fund (Article 16a (1c) and (6) of the Act).
- TUKE can also provide its students with scholarships:

- a) on the basis of concluded special contracts,
- b) from grant funds and donations.

(3) The income of the scholarship fund according to (2b) of this Article is at least 20 % of the income from tuition fees for concurrent study and the above-standard length of study according to Article 92 (5 and 6) of the Act (according to Article 92 (20) of the Act).

At least 10% of the income from tuition fees for concurrent study (Article 92 (5) of the Act) and for the above-standard length of study (Article 92 (6) of the Act) is the income of the TUKE scholarship fund and 10 % of the income from tuition fees for concurrent study (Article 92 (5) of the Act) and for the above-standard length of study (Article 92 (6) of the Act) is the income of the scholarship fund of individual TUKE faculties.

TUKE provides students with the following scholarships:

- a) social scholarships from the state budget according to Article 96 of the Act (Article 2 of these Regulations),
- b) merit scholarships from the state budget according to Article 96 (a) of the Act (Article 3 of these Regulations),
- c) scholarships from TUKE's own resources according to Article 97 of the Act (Article 4 of these Regulations).

(4) TUKE or the faculty shall award a scholarship to a student who meets the conditions stipulated by the Act and these Scholarship Regulations.

(5) The Rector awards a scholarship to students studying study programmes at TUKE and determines the dates of scholarships payments. The respective Dean awards a scholarship to students studying study programmes at one of the TUKE faculties and determines the dates of scholarships payments.

(6) If a student has used a scholarship as a service of the social support system for a purpose other than that for which it is intended, or if he has used it despite not being entitled to it, or if he has otherwise misused this support, he commits a disciplinary offense (Article 94 (6) and Article 72 of the Act).

**Article 2**

**Social scholarship**

(1) The social scholarship is awarded to TUKE students from the state budget's subsidy intended for this purpose in accordance with the Decree of the Ministry of Education of the Slovak Republic No. 102/2006 Coll. on awarding social scholarships to university students as amended, and Act No. 601/2003 Coll. on the minimum subsistence level and on the change and supplements on some acts as amended.

(2) The social scholarship is awarded to students of bachelor's, engineering and master's study programmes and study programmes according to Article 53 (3) of the Act, who have a permanent residence in the Slovak Republic and meet the established conditions. The social scholarship is provided to cover the costs connected with the study. The student has a legal right to the social scholarship.

(3) Not entitled to the social scholarship is the student (Article 96 (2) of the Act):

- a) who is studying a first level study programme, if he has already obtained higher education of the first level,
- b) who has already obtained higher education of the second level,

- c) who has been awarded the social scholarship in the respective year of study or in its part in the study programme of the respective higher education level; the period during which the student received the social scholarship in the respective year of study is rounded up to whole years,
- d) who is studying respective study programme for longer than its standard length of study; or
- e) who is studying part-time form of study.

(4) A student with special needs may be awarded the social scholarship even after exceeding the standard length of study, if this exceeding is caused by his specific needs.

(5) The income of the student and jointly assessed persons is decisive for the award of the social scholarship. The income limit for entitlement to the social scholarship and the amount of the social scholarship are derived from the minimum subsistence level amounts determined by a special regulation.

(6) The income decisive for the assessment of the entitlement to the social scholarship, the circle of jointly assessed persons, the limit of income for the entitlement to a social scholarship, its amount and other details on the award of a social scholarship are established by the Decree of the Ministry of Education of the Slovak Republic No. 102/2006 Coll. on awarding social scholarships to university students as amended, and Act No. 601/2003 Coll. on the minimum subsistence level and on the change and supplement of some acts as amended.

(7) The Rector or the Dean of the faculty, which ensures the relevant study programme, decides on the eligibility of the entitlement to the award of the social scholarship (Article 13 (1) of the TUKE Statute). If a student does not meet the conditions for the award of the social scholarship, the social scholarship will not be awarded.

(8) TUKE or the faculty provides the social scholarship in a monthly amount no later than the tenth day of the respective calendar month to a bank account held in the Slovak Republic, the number of which shall be stated by the student in the application for the social scholarship.

### **Article 3**

#### **Merit scholarship from the state budget**

(1) TUKE awards the merit scholarship from the state budget to students according to Article 96a of the Act.

(2) The merit scholarship may be awarded to a TUKE student for:

- a) study in the fields of study determined in the methodology according to Article 89 (8) of the Act on the basis of analysis and forecasts of the development of the labour market, taking into account the study results from the previous study; in the case of a student of a study programme of the first level, in the first year of study the study results from the last year of study at a secondary school shall be taken into account (Article 96a (1a) of the Act),
- b) excellent fulfilment of study obligations, i.e. for excellent study results,
- c) achieving an excellent result in the field of study,
- d) achieving an excellent result in the field of research or development,
- e) achieving an excellent result in artistic or sporting activities.

(3) Scholarships according to (2a) to (2e) of this Article are awarded by the Dean.

(4) Scholarship according to (2) of this Article can be awarded only to a TUKE student who has met the set criteria according to Article 5 of these Regulations for the assessed period. In the decision to award a scholarship, the amount of the merit scholarship and the justification for its award are stated.

(5) Scholarship according to (2a) to (2e) of this Article is granted to the student in the second and next year of study automatically on the basis of meeting the criteria set out in Article 5 of these Regulations as of 30 September of the calendar year by the Dean. This scholarship is paid in a lump sum no later than the end of the calendar year.

(6) Scholarship according to (2a) of this Article is awarded to a maximum of fifty per cent of students of the given field of study at the faculty. Scholarship according to (2b) of this Article is granted to a maximum of ten per cent of faculty students.

(7) Number of students who will be awarded a scholarship according to (1) of this Article and the amount of merit scholarships according to (2a) of this Article, are determined by TUKE special internal regulation.

### **Article 4**

#### **Scholarship from TUKE's own resources**

(1) TUKE and TUKE faculties award scholarships from their own resources on the basis of the possibilities of the scholarship fund (Article 97 of the Act) to:

- a) a TUKE student,
- b) a graduate not later than 90 days since the proper completion of studies at TUKE.

(2) Scholarship from TUKE's own resources can be awarded to a TUKE student:

- a) for excellent fulfilment of study obligations, i.e. for excellent study results,
- b) for achieving an excellent result in the field of study,
- c) for achieving an excellent result in the field of research or development,
- d) for achieving an excellent result in artistic or sporting activities.
- e) for active contribution to the development of TUKE or the faculty,
- f) as one-time or regular social support.

(3) Scholarship according to (1) of this Article can be awarded only to a TUKE student or a graduate who has met the set criteria according to Article 5 and Article 6 of these Regulations for the assessed period. In the decision to award a scholarship, the amount of the scholarship and the justification for its award are stated.

(4) Scholarship according to (1) of this Article is awarded by the Rector or Dean to the student after meeting the set criteria on the basis of proposals from faculties, school-wide workplaces or employees responsible for artistic or sporting activities, which they submit as of 31 March or as of 31 October of the calendar year. Applicant for a scholarship according to (1b) of this Article submits an application as of 31 May of the calendar year.

(5) A student who has achieved an excellent result in the field of study, research, development, artistic or sporting activities at the national or international level, has successfully represented TUKE or Slovakia, or actively contributed to the development of TUKE, is awarded a scholarship according to (1) of this Article by the Rector on the proposal of the vice-Rector for education.

(6) The scholarship from TUKE's own resources is not claimable.

(7) Scholarship according to (2a) to (2e) of this Article shall be paid in a lump sum. Scholarship according to (2f) of this Article shall be paid as a one-time or as a regular benefit.

### Article 5

#### **Criteria for the award of the merit scholarship from the state budget and the scholarship from TUKE's own resources awarded by the Dean**

(1) Scholarship according to Article 3 and Article 4 of these Regulations may be awarded to a student only on the basis of the results obtained during the assessed period.

(2) The assessed period for a scholarship for excellent study results according to Article 3 (2a) and (2b), and according to Article 4 (2a) of these Regulations is the entire previous period of study of the respective study programme or study programme in the same or related field of study; if it is a student of the first level study programme in the preferred field of study according to Article 3 (2a) of these Regulations, in the first year of study, the study results from the last year of study at a secondary school shall be taken into account.

(3) The assessed period for the scholarship according to Article 3 (2c) to (2e) of these Regulations is the semester of study preceding the semester in which the date of submission of the student's application for a scholarship was.

(4) Scholarship for excellent study results according to Article 3 (2b) and according to Article 4 (2a) of these Regulations may be awarded to a student of bachelor's, engineering or master's study programme who meets the following conditions for the assessed period:

- a) was enrolled in the study of a given study programme or study programme in the same or related field of study in the previous academic year not later than on 31 October,
- b) has successfully completed all enrolled compulsory and compulsory optional courses, which correspond to the completed part of the study according to the recommended study plan of the given study programme, with the exception that some of these courses may be replaced by courses completed by the student within academic mobility,
- c) obtained on average at least 30 credits for each semester of study, while only credits obtained for courses completed during the assessed period are included, including credits transferred within academic mobility (i.e. credits for recognized courses are not included),
- d) was included among 10 % of the total number of students of the faculty in a given level and year of the recommended curriculum and the form of study, who achieved the best weighted study average (Vp).<sup>1)</sup>

The criterion for determining the amount of the scholarship:

The student reached the weighted study average (Vp) <sup>1)</sup>	Maximum amount of the scholarship <sup>2)</sup>

<sup>1)</sup>  $Vp = \frac{\sum(P_i K_i)}{\sum K_i}$ , where  $P_i$  is the classification grade expressed as a percentage gain from the  $i$ -th course and  $K_i$  is the number of credits for the  $i$ -th course. The weighted study average Vp includes all courses enrolled for the assessed period, including courses graded by Fx. In case of equality of Vp, the average number of terms needed to pass one exam decides on the final placement of the student.

(5) The criterion for awarding a scholarship for achieving an excellent result in the field of study according to Article 3 (2c) and according to Article 4 (2b) of these Regulations is:

(6) The criterion for awarding a scholarship for achieving an excellent result in the field of research<sup>1)</sup> or development<sup>1)</sup> according to Article 3 (2d) and according to Article 4 (2c) of these Regulations is:

a) student of a bachelor's, engineering or master's study programme has received an official award	<b>Maximum amount of the scholarship</b> <sup>2)</sup>
a1) at an international conference/competition/exhibition	H
a2) at a national scientific and professional conference/competition/exhibition	H/2

b) student of the bachelor's, engineering or master's study programme is the author or co-author of an article published	<b>Maximum amount of the scholarship</b> <sup>2)</sup>
b1) in a Current Contents journal	AP x 2H
b2) in a journal indexed in the Web of Science database	AP x H
b3) in a foreign non-indexed journal	H/2

(7) The criterion for awarding a scholarship according to Article 3 (2e) and according to Article 4 (2d) of these Regulations is:

Official award of a student of a bachelor's, engineering, master's or doctoral study programme for achieving an excellent result in artistic or sporting activities, by which the student has demonstrably successfully represented	<b>Maximum amount of the scholarship</b> <sup>1)</sup>
a) the faculty or the Slovak Republic at an international competition/exhibition	H
b) the faculty at a national competition/exhibition	H/2
c) the faculty at an international competition/exhibition	H/2

<sup>1)</sup> The basis for calculating the amount of the "H" scholarship is specified in (10) of this Article.

(8) Scholarship for active contribution to the development of the faculty according to Article 4 (2e) of these Regulations may be awarded to a student of a bachelor's, engineering, master's or doctoral study programme by a Dean of the respective faculty for activities that significantly contribute to the development of the faculty and go beyond the student's duties. The maximum amount of the scholarship is "H". The basis for calculating the amount of the "H" scholarship is specified in (10) of this Article.

(9) The criterion for awarding a scholarship as a one-time or regular social support according to Article 4 (2f) of these Regulations is the consent of the Rector or the Dean of the respective faculty. The maximum amount of the scholarship is "2H". The basis for calculating the amount of the "H" scholarship is specified in (10) of this Article.

(10) The basis for calculating the amount of the "H" scholarship for the relevant academic year shall be determined by the Rector and it will be depending on the amount of funds earmarked for scholarships according to Article 3 and Article 4 of these Regulations. The highest possible value of "H" is equal to 1.5 times the basis for determining the tuition fees for the relevant academic year according to Article 92 (1) of the Act.

(11) Scholarship according to Article 3 and Article 4 of these Regulations cannot be awarded and paid to a student:

- a) who studies in a given level and in a given field of study longer than the standard length of the given study programme; this does not apply to the awarding of scholarships from own resources,
- b) during the interruption of studies, when according to the Act he/she is not a student,
- c) during a disciplinary measure and if a period of conditional expulsion from studies is running,
- d) if the student has already been awarded a scholarship for the same result.

## **Article 6**

### **Criteria for awarding the scholarship from TUKE's own resources awarded by the Rector**

(1) Scholarship according to Article 4 (2) of these Regulations may be awarded to a student only on the basis of the results obtained during the assessed period.

(2) The assessed period for the scholarship according to Article 4 (2b) to (2f) of these Regulations is the semester of study preceding the semester in which the date of submission of the student's application for a scholarship was.

(3) Scholarship for excellent study results according to Article 4 (2b) of these Regulations may be awarded to a student of a bachelor's, engineering or master's study programme by the Rector after considering the fulfilment of the criteria according to Article 5 (4a) to (4d) of this Regulations, who has achieved excellent results in the field of study. The amount of the scholarship is a maximum of 3H.

(4) Scholarship for achieving an excellent result in the field of research and development according to Article 4 (2c) of these Regulations, may be awarded to a student of a bachelor's, engineering, master's or doctoral study programme by the Rector for student's demonstrably above-standard results in the field of research and development.

(5) Scholarship for achieving an excellent result in artistic or sporting activities according to Article 4 (2d) of these Regulations may be awarded to a student of a bachelor's, engineering, master's or doctoral study programme by the Rector for the successful representation of a university in the field of artistic or sporting activities at the national or international level.

(6) Scholarships for active contribution to the development of TUKE according to Article 4 (2e) of these Regulations may be awarded to a student of a bachelor's, engineering, master's or doctoral study programme by the Rector for activities in the development, promotion or formation of TUKE and its departments, which go beyond the student's duties.

(7) The awarding of a scholarship as a one-time or regular social support according to Article 4 (2f) of these Regulations is considered individually by the Rector. The maximum amount of the scholarship is "2H". The basis for calculating the amount of the "H" scholarship is determined in Article 5 (10) of these Regulations.

(8) The amount of the scholarship according to (5) to (7) of this Article is determined by the Rector on the basis of the financial possibilities of the fund for scholarship from own resources, but as a rule, a one-time scholarship does not exceed the amount of H.

(9) Scholarships according to (4) to (8) of this Article are granted by the Rector on the basis of proposals from faculties, school-wide workplaces or responsible employees for fields according to Article 4 (2d) to (2e) of these Regulations.

(11) A scholarship according to Article 3 of these Regulations cannot be awarded and paid to a student:

- a) during the interruption of studies, when according to the Act he/she is not a student,
- b) during a disciplinary measure and if a period of conditional expulsion from studies is running,
- c) if the student has already been awarded a scholarship for the same result.

## **Article 7**

### **Corporate scholarships**

(1) TUKE or the faculty may conclude a contract with an entrepreneur (according to Article 2 (2) of the Commercial Code) on a scholarship program for the provision of corporate scholarships. The contract on the scholarship program for the provision of corporate scholarships contains the requirements according to Article 97a (3) of the Act.

(2) The purpose of a corporate scholarship is to support study in selected study programmes or to motivate the choice of a certain topic of the thesis. A student has no legal right to the corporate scholarship.

(3) The average monthly amount of the corporate scholarship provided to a student in one academic year must not exceed four times the amount of the minimum subsistence level of one natural person of age.

(4) The corporate scholarship is provided on the basis of a written application of the student.

(5) The fulfilment of the conditions for the provision of the corporate scholarship is assessed together by TUKE/faculty and the entrepreneur. The TUKE/faculty will notify the student of the award of the corporate scholarship, including the conditions of its provision in writing.

(6) TUKE/faculty is entitled to provide the entrepreneur and the entrepreneur is entitled to process the student's personal data, which are necessary to assess the right of the student to be provided with a corporate scholarship and to verify the duration of the conditions for its provision.

## **Article 8**

### **Pregnancy scholarship from the state budget**

(1) A pregnant student who has a permanent residence in the Slovak Republic and is not entitled to a pregnancy benefit in the period from the beginning of the 27<sup>th</sup> week before the expected date of birth determined by a doctor, is provided with a pregnancy scholarship by TUKE from the state budget according to Article 96b of the Act mainly for higher expenses related to the medical condition of the student, special material needs and preparation for the birth of a child. A student has a legal right to a pregnancy scholarship.

(2) For the purposes of the pregnancy scholarship, a person whose studies have been interrupted due to pregnancy is also considered a student.

(3) The amount of the pregnancy scholarship is EUR 200 per month. The government may set a different amount of the pregnancy scholarship by regulation.

(4) The pregnancy scholarship is provided on the basis of a student's written application accompanied by a medical certificate stating that she started the 27<sup>th</sup> week before the expected date of birth determined by a doctor and a confirmation from the Social Insurance Agency that she was not entitled to pregnancy benefit.

(5) The Rector decides on the provision of the pregnancy scholarship.

(6) The pregnancy scholarship is provided from the first day of the calendar month in which the application was submitted.

(7) If the conditions for the provision of a pregnancy scholarship have been met only for the part of the calendar month in which the application was received, the pregnancy scholarship shall be awarded for the entire calendar month. The pregnancy scholarship is also provided for the months of July and August.

(8) TUKE provides the pregnancy scholarship in a monthly amount no later than the tenth day of the respective calendar month to a bank account held in the Slovak Republic, the number of which shall be stated by the student in the application for the pregnancy scholarship.

(9) Entitlement to the pregnancy scholarship expires:

a) by entitlement to the payment of parental allowance after the birth of the child for which the student is provided the pregnancy scholarship,

b) by entitlement to the payment of pregnancy benefit,

c) by termination of pregnancy; or

d) by termination of studies.

(10) The student shall notify TUKE of the fact according to (9a) (9b) or (9c) within ten working days of the day of its occurrence.

(11) A person who has been provided with the pregnancy scholarship and paid a pregnancy benefit for the same period is obliged to return the provided pregnancy scholarship for the relevant period to the university.

(12) For the purposes of proving the entitlement according to (1), ascertaining, verifying and controlling the correct procedure of proving the entitlement to the pregnancy scholarship, protection and claiming the rights of the student and TUKE, TUKE is entitled to process the student's personal data to the extent necessary to award a pregnancy scholarship. For these purposes, TUKE is entitled, even without the consent of the data subject, to obtain his personal data by copying, scanning or other recording of official documents on an information carrier to the extent necessary to achieve the purpose of processing.

## **Article 9**

### **Doctoral scholarship**

(1) The doctoral scholarship is provided to all students of unpaid full-time doctoral study programmes during the standard length of study of the study programme to which they were admitted, if they have not already obtained higher education of the third level.

(2) The doctoral scholarship may have two parts:

a) claimable – a regular monthly monetary value paid during the entire academic year,

b) non-claimable – for excellent results in studies and in scientific, research and pedagogical activities.

(3) Scholarship according to (2a) of this Article is provided by TUKE or the faculty:

a) until the passing of a dissertation examination, at least in the amount of the 6<sup>th</sup> pay grade and the 1<sup>st</sup> step according to Act No. 553/2003 Coll. on the Remuneration of Certain Employees in the Performance of Work in the Public Interest and on the change and supplement to some acts as amended by subsequent provision,

b) after the passing of a dissertation examination, at least in the amount of the 7<sup>th</sup> pay grade and the 1<sup>st</sup> step according to Act No. 553/2003 Coll. on Remuneration of Certain Employees in the Performance of Work in the Public Interest and on the change and supplement to some acts as amended by subsequent provision.

(4) Scholarship according to (2b) of this Article is recognized by the Rector or the Dean on the proposal of the Committee of the doctoral study as a one-time or as a monthly monetary value paid during a specified period in the academic year, according to the amount of funds earmarked for this purpose.

#### **Article 10**

##### **Other scholarships**

(1) Scholarships provided to students on the basis of special contracts are governed by the provisions of these contracts.

#### **Article 11**

##### **Final provisions**

(1) The Scholarship Regulations of the TUKE Faculty may regulate further details in accordance with the Act, these Scholarship Regulations and other internal regulations of TUKE.

(2) The issues related to TUKE scholarships, which are not explicitly regulated in these TUKE Scholarship Regulations, are in the competence of the Rector.

(3) The TUKE Scholarship Regulations, their changes and supplements shall enter into force and effect upon their approval by the Academic Senate of TUKE.

(4) The TUKE Scholarship Regulations from 01 June 2009 and effective from 01 September 2009 are ceased to have effect.

(5) These TUKE Scholarship Regulations were approved by the Academic Senate of TUKE on 07 June 2010, resolution number 20/2010 and come into effect on 01 July 2010.

(6) Amendment No. 1 to the TUKE Scholarship Regulations was approved by the Academic Senate of TUKE on 22 November 2010, resolution number 46/2010 and come into effect on 23 November 2010.

(7) Amendment No. 2 to the TUKE Scholarship Regulations was approved in the Academic Senate of TUKE on 21 May 2012, resolution number 17/2012 and come into effect on 01 June 2012.

(8) Amendment No. 3 to the TUKE Scholarship Regulations was approved in the Academic Senate of TUKE on 24 June 2013, resolution number 25/2013 and come into effect on 01 July 2013.

(9) Amendment No. 4 to the TUKE Scholarship Regulations was approved in the Academic Senate of TUKE on 21 April 2017, resolution number 10/2017 and come into effect on 01 September 2017.

(10) Amendment No. 5 to the TUKE Scholarship Regulations was approved by the Academic Senate of TUKE on 06 November 2017, resolution number 48/2017 and come into effect on 07 November 2017. The Academic Senate of TUKE also approved the issuance of the full text of the Scholarship Regulations of TUKE.
