### **RECTOR'S DIRECTIVE no. 12/2020**

#### ON THE RELEASE OF MEASURES RELATED TO THE RISK OF COVID-19 DISEASE CAUSED BY CORONAVIRUS

Given the favourable epidemiological situation in the Slovak Republic and surrounding countries, the gradual release of measures against the spread of COVID-19, and related measures taken by the Government of the Slovak Republic and the Public Health Office of the Slovak Republic, I hereby issue the following Rector's Directive of the Technical University of Košice (hereinafter "TUKE"):

# I. I hereby c a n c e l , as of June 7, 2020:

- 1. Rector's Directive no. PR/TUKE/03/20 on reducing the risk of infection by the coronavirus COVID-19 in its entirety.
- 2. Rector's Directive no. PR/TUKE/04/20 on reducing the risk of infection by the coronavirus COVID-19 in its entirety.
- 3. Rector's Directive no. PR/TUKE/05/20 on reducing the risk of infection by the coronavirus COVID-19 in its entirety.
- 4. Rector's Directive no. PR/TUKE/06/20 on reducing the risk of infection by the coronavirus COVID-19 in its entirety.
- 5. Rector's Directive no. PR/TUKE/07/20 on reducing the risk of infection by the coronavirus COVID-19 in its entirety.
- 6. Rector's Directive no. PR/TUKE/09/20 Work-related measures at TUKE during the period of preventive measures related to the COVID-19 disease, as amended by the amendment no. 1 in its entirety.

# II. I hereby order, with effect from June 8, 2020:

- 1. To continue to comply with all hygienic and anti-epidemic measures and guidelines, which are regularly updated by the Government Office of the Slovak Republic and the Public Health Office of the Slovak Republic, and which relate to protective and safety measures at the workplace in connection with the COVID-19 disease.
- 2. To follow and comply with current statements of the Government Office of the Slovak Republic, recommendations of the Ministry of Education, Science, Research and Sport of the Slovak Republic, the Ministry of Foreign and European Affairs of the Slovak Republic and measures and guidelines of the Public Health Office of the Slovak Republic, on matters related to:
  - a) accommodation and provision of meals to students and employees of TUKE,
  - b) education, science and research activities
  - c) operation of sports facilities, recreational facilities and short-term rentals,
  - d) business trips abroad,
  - e) admission of students and staff from abroad,
  - f) organizing mass events on the TUKE campus.

## III. Final provisions

1. Rector's Directive no. PR/TUKE/08/20 on ensuring the educational process in levels 1, 2 and 3, state examinations and accommodation in student dormitories in connection with the emergency situation remains in force without changes.
